The results of such candidates will be declared after final outcome of the court/CAT cases and/or a final decision regarding their eligibility to appear in the examination is taken by the respective Circle offices and communicated to the BSNL Corporate Office. The results are subject to final outcome of OA No. 773/2001 filed in the Ernakulam Bench of Hon'ble CAT and O.P. No. 26923 filed in the Hon'ble High Court of Kerala at Ernakulam and in any other cases that may be pending before any Bench of the Hon'ble CAT/any High Court. The results of the candidates belonging to ASTT cadre who were admitted provisionally to the examination by Office of the CGM Kerala have also been with held and would be declared after a decision regarding their eligibility is received.


